James Delia, Esquire, representing applicant.

Mr. Delia stated that began renovating Bergen Town Center eleven years ago and spent considerable time on a sign master plan – Best Buy to be a tenant on east side, Building “H” – two signs – 502 SF originally approved – proposed exceeds roof line.

Burlington is moving in on west site – looking for sign containing 16 SF logo – wall sign on Forest – rent space on second floor. Also have construction zone, Phase 2, which requires temporary signs for safety. Require signage for Drive Assist which tells customers which spaces are available in garage – some temporary signage already up for emergency safety on site

Mr. McKenna questioned the effect of multiple lighted signs.

Linda Kreczkowski, Architect. Stated prepared plan – Best Buy building one story – two faces – described plan – identical signs – feel appropriate – signs facing west site and Route 4.

Witness described 4 x 4 heart shape Burlington logo, not illuminated – wall signs are LED. Park Assist allows patrons to see which parking spaces are available in garage, red, green, blue lights – sign extends 4'-8" off building. Temporary signs are needed for construction site – not illuminated, canvas - more like banners – “way finder” signs are for stores in that location, just for directional use.

In reply to Mr. Lagana, Mr. Delia said other stores have logos – size of Burlington sign falls right in line with others.

Mr. Cirillo questioned handicap spaces in garage and time frame for construction. Mr. Ten Hoeve suggested that temporary signs be removed by end of August.

Brigette Bogart, Planner. Ms. Bogart explained that remodel started 11 years ago - made comprehensive sign plan – proposed signs keeping with objectives. Building “H” on east site last to be developed – difficult to access. Burlington sign with logo on west side – creating pedestrian oriented site. Feel signs are good civic design – creating outside appeal – benefits outweigh detriments – signs do not face residents.

Messrs. Lagana and Ricchiuti questioned Best Buy signs in relation to Whole Foods signs.

Mr. Delia advised Board that signs were adding to harmony – temporary and Park Assist are necessary for function – feel request is justified.

Motion by Cirillo, seconded by Gunderson, to approve UE East signs,
