#### Discussion:

Mr. Kohut, the applicant's attorney describes this application for the Board which includes exterior modifications to enhance this retail building. The applicant proposes to increase the height of the western portion of the building and to redesign the front of the building. The redesigning of the entrance will increase the building coverage by 0.3%. Mr. Kohut introduces Mr. Scott Monro, Architect, for the applicant. Mr. Monro describes the changes to this building which will have no changes to landscaping, lighting or signage. Mr. Kohut also had Mr. Glen Reda, Architect who drew the plans testify as to plans. The Board agrees to the property drainage cleaning and inspection. Board Engineer, Mr. TenKate mentions about all ADA parking spaces meet the requirements and comply. Mr. Reda describes the canopy which sticks out 3 feet will offer shade and coverage to customers entering the building.

## Discussion:

Board Engineer, Mr. TenKate reviews a memo that he sent to the Planning Board regarding recommended revisions for the Borough Code Site Plan and Zoning Code sections. Mr. TenKate describes the first two of the four recommendations. The first recommendation, pertains to allow the height of roof top mechanicals in HCC or HCC-2 Zones. The second recommend revision, pertains to future parking. The last two recommended revisions, our Board Planner, Mr. Reiner described for the Board. The third recommendation pertains to parking requirements in the HCC Zone. The fourth recommended change pertains to multi-family residential developments prohibiting residential units on the ground floor. The Board agree to these four revisions to the Borough Code and asked Board Attorney, Mr. Pellino to draft a letter to our Mayor and Council with said recommendations.
