**AN ORDINANCE TO REPEAL AND REPLACE PART II, GENERAL LEGISLATION,
CHAPTER 419, VEHICLES AND TRAFFIC, ARTICLE VI, SCHEDULES,
SUBSECTION 419-56, SCHEDULE XIV: PARKING PROHIBITED AT ALL TIMES
OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF PARAMUS**

BE IT ORDAINED, by the Mayor and Council of the Borough of Paramus, County of Bergen and State of New Jersey that Part II, General Legislation, Chapter 419, Vehicles and Traffic, Article VI, Schedules, Subjection 419-56, Schedule XIV: Parking Prohibited at All Times, of the Code of the Borough of Paramus, is hereby repealed and replaced as follows:

Section 1. The current text of Borough Ordinance, Part II General Legislation, Chapter 419, Vehicles and Traffic, Article VI, Schedules, Subjection 419-56, Schedule XIV: Parking Prohibited at All Times, of the Code of the Borough of Paramus, is hereby repealed as follows:

§ 419-56 Schedule XIV: Parking Prohibited at All Times.

In accordance with the provisions of § 419-19, no person shall park a vehicle at any time upon any of the following described streets or parts thereof:

Name of Street	Side	Location
Green Valley Road	North	Between east curbline of Tuers Lane and 167 feet east thereof

Section 2. The current text of Borough Ordinance, Part II General Legislation, Chapter 419, Vehicles and Traffic, Article VI, Schedules, Subjection 419-56, Schedule XIV: Parking Prohibited at All Times, of the Code of the Borough of Paramus, is hereby replaced with the following:

§ 419-56 Schedule XIV: Parking Prohibited at All Times.

In accordance with the provisions of § 419-19, no person shall park a vehicle at any time upon any of the following described streets or parts thereof:

Name of Street	Side	Location
Roosevelt Boulevard	East	From the point 450' south of the south curb line of Diaz Place to the transition to Green Valley Rd.
Roosevelt Boulevard	West	From the south curb line of Willow brook Ct to the transition to Green Valley Rd.
Green Valley Road	North/West	From the west curb line of Beech Lane to 200' South/West thereof.

Green Valley Road, North From the east curb line of Tuers Lane north/east to the transition to
Roosevelt Blvd.

Section 3. Any ordinance or part thereof inconsistent with this ordinance is repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect following adoption and approval in a time and manner provided by law
