IMPORTANT NOTICE

Late Fee Schedule

Effective May 1, 2001, the Mayor and Council has adopted the following late fees for licenses:

Foodhandling Licenses

1. A fifty dollar (\$50.00) late fee shall be charged on all license fees of \$400.00 or less which are not paid on or before February 1st of the license year. An additional \$50.00 shall be charged for each thirty-day period that the license fee is not paid after February 1st of the license year.
2. A seventy-five dollar (\$75.00) late fee shall be charged on all license fees of \$500.00 or greater which are not paid on or before February 1st of the license year. An additional \$75.00 shall be charged on each thirty-day period that a license fee is not paid after February 1st of the license year.

Vending Machine Licenses & Electronic Smoking Devices

1. A twenty-five dollar (\$25.00) late fee shall be charged on all vending machine licenses and electronic smoking devices which are not paid on or before February 1st of the license year. An additional \$25.00 shall be charged for each thirty-day period that the vending machine fee is not paid after February 1st.
